Terms and conditions:-

1. Bidders are required to super scribe as **“Renovation of broken boundary wall at North side (Nursery bed area)”** on the body of envelope.
2. The earnest money deposit as mentioned in the e-quotation notice or equivalent to 2% of the estimated value in shape of demand draft/banker cheque drawn in favour of the Director, NRRRI, Cuttack, payable at State Bank of India, Nayabazar, Cuttack-4 (Code No. 2094) should be deposited along with the quotation without which the quotation will be rejected. Demand draft drawn before the date of issue of the tender will not be considered. In the event of the offer made by the tenderer not being accepted, the EMD will be refunded to the tenderer.
3. An amount equal to 5% of the work bill is required to be deposited as DLP with NRRRI by the contractor who executes the work before payment of the bill. If it is not deposited, NRRRI will deduct the amount from the bill. DLP will be returned after 6 months / 1 year after successful completion of the work. No interest will be paid to the tenderer by NRRRI on EMD and DLP.
4. After completion of work if within one year, any defect, or damage or poor workmanship is noticed, the same shall be rectified by the contractor within 10 days failing which the Security Deposit shall be forfeited.
5. Taxes viz Income Tax, Cess on I.T., Labour Cess and such other taxes levied by Government from time to time will be deducted from the work bill.
6. No part payment will be made for execution of the work.
7. The tenderer is required to append Photostat copy of valid certificates of registration for contractor license, IT-PAN and GST Registration else the bid will not be considered.
8. Tenderer is supposed to fill up the tender schedule without changing contents and signed duly. In case the provided schedule is insufficient, additional pages may be added at the end of the schedule. Each additional page must be signed by the tenderer and pages must be numbered consecutively.
9. Once the tender is submitted, its offered rates and other contents cannot be changed and the tenderer cannot back out from the offer.
10. Quotation will be received by AAO (Tech), NRRRI only by courier and speed/registered post. Tenderer also has the option to drop the bid in the tender box, available for the purpose in the office of the Chairman (Works Committee). Quotations will not be received after last date and scheduled time. NRRRI will not be held responsible for postal/courier delay.
11. If the tenderer (or his/her authorized agent) desires, he/she will be allowed to be present at the time of opening of the quotation. The authorized agent will have to produce authorization certificate from the bidder at the time of opening of the tender.
12. Work order will be issued to the successful bidder after completion of all formalities of NRRRI, Cuttack. The successful bidder has to enter an agreement after receipt of work order and before start of the work. If the tenderer does not start the work within 7 days of issue of work order or does not represent to the Director, NRRRI stating a valid reason such as interference of natural phenomena or the circumstances beyond his control, the work order shall be deemed to be withdrawn without any notice and EMD will be forfeited. Decision of the Director, NRRRI, Cuttack in this regard is final and binding on the tenderer.
13. Rates quoted by the bidder will be valid till completion of the work.
14. In case the work order is placed for execution, it will be incumbent on the tenderer to abide these terms and conditions and complete the work as per the schedule of works to the best satisfaction of the In charge, Engineering Section, NRRRI, failing which the EMD will be forfeited and the tenderer is liable to pay the loss to be incurred by NRRRI, to carry out the work/balance of work through any other agency.
15. If any damage occurs to NRRRI property during execution of work including dismantling the same will be borne/repared by the tenderer. For this reason, the tenderer is advised to inspect the work site before submitting the tender.

16. Director, NRRRI is not bound to accept the lowest or any other tender and also reserves the right to reject any or all the quotations without assigning any reason thereof.
17. The tenderer will abide by the contract labour act, minimum wages act and other labour related acts, applicable during execution of the work.
18. The workers will be personnel of the tenderer and NRRRI will have no responsibility whatsoever to them. Any liability that may arise due to death/injury to any of the workers while executing the work will be borne by the tenderer.
19. Overwriting/overtyping/erasing of the rates/ambiguity etc. on the bid, will not be permitted and the tender will be liable to be rejected.
20. Tender schedule must be complete in all aspects and no blank column will be allowed.
21. Quotations which do not comply with the above conditions are liable to be rejected.
22. In case of any dispute on execution or other issues related to this work, the decision of the Director, NRRRI will be final and binding.
23. Jurisdiction of the tender will be Cuttack only.
