E-tenders (in 2 bid system) are hereby invited on behalf of the OIC, CRURRS, Hazaribag for annual contract of PROVIDING JOB WORK/SERVICE CONTRACT FOR PROVIDING ALLIED SERVICES i.e. "ANNUAL CONTRACT FOR PROVIDING SECURITY SERVICES" AT CRURRS,HAZARIBAG. The terms and conditions of the contract which will govern any contract made are those contained in the General conditions of contract applicable to the contracts and the special terms and conditions are detailed in the tender forms and its schedules. Please submit your rates in the tenders form if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached schedules.

2) An earnest money of **Rs. 30,000/- (Rupees Thirty Thousand only)** must be deposited in the form of demand draft/pay order in favour of ICAR Unit,CRURRS,Hazaribag. The particulars of the earnest money deposited must also be super-scribed on the top of the envelope by indicating the draft/pay order number and date, failing which the tenders will not be opened. The tenders will not be considered if earnest money is not deposited with the tenders. However, EMD is exempted for agencies registered with National Small Industries Corporation (NSIC).

3) The tenderer is being permitted to give tenders in consideration of the stipulation on his part that after submitting his tenders, he will not rescind from his offer or modify the terms and conditions thereof. If the tenderer fail to observe and comply with the foregoing stipulation the aforesaid amount of EMD will be forfeited by the Institute. In the event of the offer made by the tenderer not being accepted, the amount of earnest money deposited by the tenderer will be refunded to him after he has applied for the same, in the manner prescribed by the Institute.

4) The Schedules of the tenders form should be returned intact and pages should not be detached. In the event of the space provided on the schedule form being insufficient for the required purpose additional pages may be added. Each additional page must be numbered consecutively and be signed in full by the tenderer. In such cases reference to the additional pages must be made in the tenders form. If any modification of the schedule is considered necessary it should be communicated by means of a separate letter along with the tenders. Overwriting/erasing in rates to be quoted by the tenderer will not be allowed otherwise the tenders may be rejected.

5) The tenders are liable to be ignored if complete information as required is not given therein or if the particulars asked for in the schedules to the tenders is not fully filled in. Individual signing the tenders or other documents connected with the contract may specify whether he signs it in the capacity of (i) a sole proprietor of the firm or constituted attorney of such sole proprietor , of (ii) a partner of the firm if it be partnership in which case he must have authority to refer to arbitration dispute concerning the business of the partnership whether by virtue of the partnership agreement or power of attorney of (iii) constituted attorney of the firm if it is a company .

6) If tenderer does not accept the offer, after issue of letter of award by Institute within 15 days, the offer made shall be deemed to be withdrawn without any notice & earnest money forfeited

7) In case of partnership firms, where no authority has been given to any partner to execute the contract/agreement concerning the business of the partnership, the tenders and all other related documents must be signed by every partner of the firm. A person signing the tenders form or any other documents forming part of the contract on behalf of another shall be deemed to warranty that he has authority to bind such other and if, on enquiry it appears that the persons so signing had no authority to do so, the OIC, CRURRS, Hazaribag *shall without prejudice to other civil and criminal remedies cancel the contract and hold the signatory liable for all cost and damages. Each page of the tenders and annexure, if any, should be signed by the tenderer.*

8) E-tender should be submitted not later than **04.07.2017 at 3.00. p.m**

9) First, Technical bids will be opened and after evaluation of Technical bids in accordance with the qualifying criteria points as indicated in check list, a list of firm qualified in Technical bids will be prepared and the date of opening of Financial bids will be reflected. The Financial bids will be opened on the prescribed date and time in the website who qualified in Technical bids: and only those firms will be considered for financial bid who will qualify in the Technical bid.

10) The printout copy of the tenders and original EMD in the form of Demand Draft is to be submitted in a closed cover super-scribed as THE JOB WORK CONTRACT FOR PROVIDING ALLIED SERVICES "ANNUAL CONTRACT FOR PROVIDING SECURITY SERVICES" AT CRURRS,HAZARIBAG with address of this office. All Tenders should be sent by Registered Post. Print outs of tender documents should reach at CRURRS, Hazaribag not later than 3.00 P.M. on **04.07.2017.**

11) The Institute is not bound to accept the lowest or any other tenders and also reserve to itself the right of accepting the tenders in whole or in part. You are however at liberty to Tenders for the whole or any portion or to state in the tenders that the rates quoted shall apply only if the tenders are considered fully. Other conditional Tenders will not be accepted.

12) The selected bidder shall have to deposit an amount of **8%** of contract value towards **Security Deposit** in the form of **Demand Draft** in favour of the **ICAR Unit, CRURRS, Hazaribag** payable at **State Bank of India, Hazaribag** to the **Assistant Administrative Officer, Central Rainfed Upland Rice Research Station, Hazaribag-825 301, Jharkhand** along with the Agreement. In the event of non-submission of the security deposit, the EMD will be forfeited. However, the EMD will be refunded on receipt of Security deposit.

13) No interest on security deposit and earnest money deposit shall be paid by the Institute to the tenderer.

14) Service Tax or any other Tax applicable or made applicable after awarding the contract in respect of this contract shall be payable by contractor and OIC, CRURRS, Hazaribag will not entertain any claim whatsoever in this respect. However the service taxes or any other tax which is as per rules of the Govt., shall be deducted at source from monthly bills of the successful tenderer, as per rules/instructions made applicable from time to time by government.

15) OIC, CRURRS, Hazaribag reserves the right to reduce or terminate the period of contract or to extend its duration in the interest of the Institute, for any justifiable reasons, not mandatory to be communicated to the tenderer.

16) Decision of OIC, CRURRS, Hazaribag shall be final for any aspect of the contract and binding to all parties. Disputes arising, if any on the contract will be settled at his/her level by mutual consultation and in case of failure of settlement dispute shall be referred to the sole arbitrator to be appointed by the OIC, CRURRS, Hazaribag. The decision of the sole Arbitrator so appointed shall be final and binding on the parties. Arbitration proceedings shall be governed by the Arbitration & Constitution Act.1996.

17) Acceptance by the Institute will be communicated by FAX/E-mail, Express letter or any other form of communication. Formal letter of acceptance and work order of the Tenders will be forwarded as soon as possible, but the earlier instructions in the FAX/E-mail/Express letter etc. should be acted upon immediately.

Scope of work:

The approximate area to be supervised for providing Security Service at CRURRS, Hazaribag is **about 120 acres**. The details of Security requirements and duties to be performed may be assessed by the service providing agencies in consultation with the I/C.F.S, CRURRS, Hazaribag and quote their rates accordingly.

TERMS & CONDITIONS:

- 1) The supporting/allied services staff should follow strict attendance and alternative arrangements are to be made by the agency whenever anyone of staff/supervisor is to go on leave under intimation to this Office.
- 2) Changing of Staff/Supervisor should be intimated to the I/C, Security, CRURRS, Hazaribag.
- 3) The OIC, CRURRS, Hazaribag reserves the right to reject any or all quotations in whole or in part without assigning any reason thereof. The decision of OIC, CRURRS, Hazaribag shall be final and binding on the contractor/Agency in respect of clause covered under the contract.
- 4) The staff provided should also maintain secrecy and discipline in the premises of Institute.
- 5) The staff provided should be capable of reading and writing Hindi and English with a minimum qualification of Middle Standard.
- 6) The Contractor shall keep a complaint register with his supervisor, and it shall be open to verification by the authorized officer of CRURRS, Hazaribag for the purpose. All complaints should be immediately attended to by the Agency.
- 7) Uniform with colour specifications and pattern approved by CRURRS, HAZARIBAG should be supplied by the contractor to the worker at his own cost and it should be ensured that the working staffs etc. are in proper uniform while on duty.
- 8) The agreement is terminable with one month notice on either side.
- 9) The contractor shall not sublet the work without prior written permission of the OIC, CRURRS, Hazaribag.
- 10) The Contractor or his workers shall not misuse the premises allotted to them for any purpose other than for which the contract is awarded
- 11) The Selected agency shall provide the necessary personnel for and at CRURRS, Hazaribag as per labour acts prevalent in Central Govt./State Govt. The agency shall employ good and reliable persons with robust health of age group of 25 to 45 years. They should be capable of preventing theft cases of undesirable elements and be conversant with use of conventional weapons. The security personnel should be dressed in proper uniforms while on duty. Any complaint against them shall be decided bilaterally with the Agency. Functional control over the security staff rests with the I/C, Security, CRURRS, Hazaribag, who will in turn function under the supervision of the OIC, CRURRS, Hazaribag of this Institute. The Agency shall be liable to pay compensation to CRURRS, Hazaribag for loss/damage due to theft/hooliganism as determined by the OIC, CRURRS, Hazaribag.
- 12) The Bidders have to submit a certificate in their letter head along with the tender that ***"Certified that the Security Personnel to be provided shall be within 25 – 45 years and that they all shall be ex-servicemen."***
- 13) The guards / supervisors, who have rendered three years services under different agencies in a go at CRURRS, Hazaribag shall not be eligible for deployment in this Institute.
- 14) The Institute will not provide any residential facility to the guards / supervisors. In case any of the personnel so provided is not found suitable by the Institute, the Institute shall have the right to ask for his replacement without giving any reason thereof and the agency shall on receipt of a written communication will have to replace such persons immediately.

- 15) The persons so provided by the agency under this contract will not be the employee of the ICAR Unit, CRURRS, Hazaribag and there will be no employer-employee relationship between the ICAR Unit, CRURRS, Hazaribag and the person so engaged by the contractor in the aforesaid services.
- 16) Payment for service contract will be made monthly upon submission of pre-receipted bill. Income Tax as applicable will be deducted at TDS only on service charges.
- 17) After physical inspection of the site, a very detailed assessment / requirements of personnel for providing security services at CRURRS, HAZARIBAG shall have to be furnished along with the Tender.
- 18) The Security Supervisors/guards to be deployed should be paid the minimum wages by the agency on the first week of the every month and the payment should be made in front of the authorized nominee of this Institute and a certificate in this regard should be furnished on the body of the bill by the I/c, Security while submitting the monthly bill.
- 19) The bidders are to quote their rates taken into account the VDA rate applicable as on **01/04/ 2017**(per watch and ward without arms)

LIQUIDATED DAMAGES CLAUSE:

1. An amount equivalent to two days of contract amount, subject to a minimum of Rs.500/- will be levied as liquidated damages per day. Whenever and wherever it is found that the work is not up to the mark in any section, it will be brought to the notice of the supervisory staff of the firm by CRURRS, Hazaribag and if no action is taken within one hour, liquidated damages clause will be invoked.
2. Any misconduct/misbehavior on the part of the manpower deployed by the agency will not be tolerated and such person(s) will have to be replaced immediately.

The OIC, CRURRS, Hazaribag reserves the right to reject any or all Tenders in whole or in part without assigning any reasons thereof. The decision of the OIC, CRURRS, Hazaribag shall be final and binding on the contractor/agency in respect of any clause under the contract.
